

2018 Little Red Organics Terms and Conditions

(Farmer - Member Agreement)

We ask all members to carefully read our terms and conditions and check “Agree.” In signing this agreement, you commit to becoming a member of Little Red Organics CSA and assume responsibility for understanding the policies and procedures of membership. By ordering a share through an online signup, you have agreed to our terms of service.

I, [member], understand that Community Supported Agriculture is a deeper relationship between farmer and consumer, and that by joining the Little Red Organics [LRO] CSA I am committing to a season-long adventure of local, healthy eating. I also commit to participate by providing feedback regarding produce, communication, systems, etc.

By joining the CSA, I understand that all regular communications will be via email.

Payments

Little Red Organics uses an online system to manage many aspects of the CSA, including payments. LRO members have online access to their personal accounts. Payments accepted include ACH (direct debits), credit card, paper check and cash. In signing up for CSA I am committing to investing the full cost of the share I have selected into the farm. This includes the membership fee (which covers part of the admin, packaging and delivery costs), my per-week share cost, as well as any add-ons.

I understand that an installment plan is available, and that payment in full is due no later than 48 hours before my first scheduled delivery.

Webstore

Each week members will be invited by email to customize their share based on product availability. The member may choose not to customize a box, and will then receive a standard “farmers’ choice” box with a variety of produce.

For those wishing to customize:

The value of the weekly box will correspond approximately to the per-week payment made (\$17/small share, \$26/medium, \$34/large), and the total value of produce for the season will match the member's full-season investment. Unlike 2017, in 2018 members are not required to use all of their weekly credit each week.

Subscription and Delivery Changes

Through the online management system members may change their share size and delivery location. This may be done at any time during the season; however, changes must be made at least 7 days prior to a delivery for share changes and 48 hours for delivery location change, otherwise those changes will take effect the following week.

Vacation Weeks

For member convenience, LRO allows unlimited vacation weeks throughout the season. Vacation weeks must be arranged no later than 7 days prior to the skipped delivery. Those taking vacation weeks can and must utilize the value of the skipped week's box during other week(s) before the end of the season. This can be done by adding extra items onto several other weeks or by using the entire amount on bulk items later in the season. Credit on your account will not roll into the 2019 season and is 'use it or lose it'

Missed/skipped pickups will be considered forfeits and are not eligible for credit.

General Information

I understand that there are inherent risks in farming, which may affect the availability of products offered by Little Red Organics. These risks include, but are not limited to: poor weather, drought, disease, early frosts, pests, and crop failure. The farm plans for such contingencies and uses growing techniques that try to protect the harvest.

On the whole, members will receive a variety of vegetables based on seasonal availability, subject to the unpredictability of farming, each week. From time to time due to uncontrollable circumstances LRO must substitute items without notice to the member. Although this seldom happens, it is an inherent risk associated with being a member of a CSA, and I agree that I am aware of this risk and will accept substitutions as must be made.

If substitutions are made, the unavailable items will be replaced with those used similarly in the kitchen, if at all possible.

Cancellation and Credit/Refund Policy

As with all CSAs, the dollars members pay are allocated early in the year to cover costs throughout the growing season. When I sign up for a share, I agree to pay the full cost of my selected share(s). Payments for members joining mid-season are prorated.

Remaining full season balances must be used by the end of the membership period for your subscription. No remaining dollars will be refunded.

If a member has not received box(es) due to non-delivery or other reasons, he/she will contact the farm within 24 hours of delivery and a box/credit will be issued, as deemed appropriate. Product will be considered received otherwise.

Major product defects or spoilage: Any claims of defects or spoilage must be reported within 24 hours of delivery. If any defect occurs the farm will issue a replacement of the product of the same value, or a credit as deemed appropriate.

Due to the perishable nature of produce, we cannot guarantee quality outside of the designated pickup times for each location.

Late pick-ups (outside the scheduled pick-up day/time) are not eligible for credits, due to natural deterioration of fresh produce. Lots of things can

happen to boxes after hours; we don't credit for any of them.

No refunds or mid-season cancellations will be offered. If a member finds him/herself in an extreme or emergency situation, they may contact the farm about options for the remainder of the season, which will be reviewed on a case by case basis.

While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
